Community Eligibility Criteria for Livelihood Support Programs

We believe in empowering communities to build sustainable livelihoods and achieve long-term economic security. Our livelihood support programs are designed to equip



communities with the tools and resources they need to overcome poverty and chart a path toward self-sufficiency.

To ensure these programs have the greatest impact, we prioritize communities that meet specific eligibility criteria. These criteria are designed to identify communities with the greatest need and the strongest potential for success. Here's a closer look at the key factors we consider when evaluating community eligibility:

Criteria	Description	
Economic Vulnerability	The community should demonstrate high levels of poverty, unemployment, or limited access to income-generating opportunities.	
Need for Livelihood Support	Factors such as low household income, food insecurity, or reliance on unstable or unsustainable livelihoods indicate a clear need for livelihood support.	
Geographical Location	Priority will be given to communities in regions with high poverty, unemployment, or economic vulnerability, including remote or marginalized areas like rural villages or urban slums.	
Capacity and Willingness to Participate	Beneficiaries must be able to execute the livelihood project and be willing to participate in relevant training. The community as a whole should demonstrate the ability and motivation to actively engage in project planning, implementation, and monitoring.	
Local Leadership and Support	A strong community leader (e.g., church pastor, social worker, teacher) with local authority and stakeholder support is crucial to oversee project implementation and ensure success and sustainability.	
Alignment with Project Objectives	Community needs and priorities should align with the livelihood project's objectives and focus areas, promoting relevance and effectiveness.	
Inclusivity and Equity	The selection process should be inclusive and equitable, considering the needs of marginalized or vulnerable groups like women, youth, persons with disabilities, and ethnic minorities.	
Sustainability	The community should exhibit a commitment to the long-term viability of the livelihood initiative, including the ability to manage and maintain project assets, resources, and activities beyond the duration of external support.	
Community Engagement and Ownership	Strong community engagement and ownership are essential, ensuring active participation in decision-making processes, project planning, and implementation. This fosters the project's relevance, effectiveness, and long-term success.

Beneficiary Eligibility Criteria

Individuals are evaluated based on several factors:

Factor	Description		
Economic Need	Assessed through income level, assets, and economic activities. This ensures support reaches those with the greatest financial need.		
Vulnerability	Individuals are most affected by circumstances like childhood (orphans), widowhood, disability, age, or disasters. This prioritizes those facing significant challenges.		
Skills and Capacity	Existing skills and training relevant to proposed livelihood activities. This ensures beneficiaries are well-positioned to benefit from the offered support.		
Geographic Focus	Proximity to project sites, considering rural/urban needs. This targets beneficiaries within the intended reach of the project and addresses specific local needs.		
Motivation and Commitment	Willingness to participate actively and achieve project goals. This ensures beneficiaries are invested in the program and its success.		
Household Composition	Family size and dependents are considered to assess the impact on potential activities. This ensures support takes into account the needs of the entire household.		
Gender and Social Inclusion	Promoting equity by considering the specific needs of women, minorities, youth, and the elderly. This ensures the program is inclusive and reaches a diverse range of beneficiaries.
